2024 FEE SCHEDULE

DEAR BUSINESS OWNER OR MANAGER:

Enclosed is your annual weighing and measuring device and/or point of sale (POS) terminal registration notice and fee for the period of January 1st –December 31st. Pursuant to Section 12240 of the California Business and Professions Code (BPC) and Title 3, Chapters 3.64 and 3.72 of the Alameda County Municipal Code (ACMC), each person responsible for the use of a commercial weighing, measuring and/or POS device(s) shall register their device(s) with the County Sealer of Weights and Measures annually. It is unlawful to operate a weighing, measuring and/or POS device without being registered for the current calendar year.

Please note- 2023 CA Assembly Bill 1304 raised the allowable registration fees to align with current costs of inspection and oversight, which is reflected in the below fee schedule.

Registering your device(s) helps to protect the buyer and seller from inaccurate or incorrect transactions.

It is the responsibility of the device owner/user to ensure the device is maintained in proper working condition at all times.

There will be a re-inspection or call back charge for devices found to be incorrect on the initial or subsequent inspection(s).

DEVICE REGISTRATION FEE SCHEDULE:

General Weighing & Measuring Devices (Not Listed Below)	\$120 per location or vehicle + \$26/device (\$1,200 maximum per Location) + ADF \$2.20/device
Scales (other than Livestock) greater than 10,000 lb. -	\$120 per location + \$250/scale + ADF \$24.00/scale
Scales (other than Livestock) 2,000 to 10,000 lb. -	\$120 per location + \$150/scale + ADF \$16.00/scale
Scales (other than Livestock) 100 lb. to less than 2,000 lb. -	\$120 per location + \$50/scale + ADF \$2.20/scale
Livestock Scales greater than 10,000 lb. -	\$120 per location + \$150/scale + ADF \$24.00/scale
Livestock Scales 2,000 to 10,000 lb. -	\$120 per location + \$100/scale + ADF \$16.00/scale
Computing Scales less than 100 lb. -	\$120 per location + \$25/device (\$1,200 maximum per Location) + ADF \$2.20/scale
Prescription, Jewelry, and other Class II Scales -	\$120 per location + \$80/scale + ADF \$2.20/scale
Stationary & Truck Mounted LPG Meters -	\$120 per location + \$185/meter + ADF \$16.00/meter
Compressed Natural Gas and Liquefied Natural Gas -	\$120 per location + \$185/meter + ADF \$16.00/meter
Wholesale & Vehicle Meters -	\$120 per location + \$75/meter + ADF \$2.20/meter
Vehicle Odometers utilized to charge fees -	\$120 per location or vehicle + \$60/device (\$340 maximum per Location) + ADF \$2.20/device
Water Sub-meters -	\$120 per location + \$6/meter + ADF \$0.50/meter
Electric Sub-meters -	\$120 per location + \$3/meter + ADF \$0.50/meter
Vapor Sub-meters -	\$120 per location + \$10/meter + ADF \$0.50/meter
Automated Point of Sale Terminals (Scanners) -	\$150 per location for 1-3 scanners <u>or</u>
	\$225 per location for 4 or more scanner

IMPORTANT NOTE: A PENALTY OF UP TO 100% OF THE BALANCE OWED WILL BE ASSESSED FOR ALL LATE PAYMENTS. FAILURE TO PAY AND REGISTER YOUR DEVICE(S) MAY RESULT IN PROSECUTION BY ALAMEDA COUNTY DISTRICT ATTORNEY’S CONSUMER FRAUD UNIT.

RE-INSPECTION/REQUESTED INSPECTION FEE SCHEDULE:

SCALES (MANUFACTURER’S RATED CAPACITY)

Small Capacity Scales - 0-50 lb., inclusive	\$ 110.00 per hour + \$110.00 trip fee or \$ 1.50/mile whichever is greater
Medium Capacity Scales Greater than 50 lb. to 5,000 lb. inclusive	\$ 125.00 per hour + \$125.00 trip fee or \$ 1.50/mile whichever is greater
Large Capacity Scales greater than 5,000 lb inclusive	\$ 135.00 per hour + \$165.00 trip fee or \$ 1.50/mile whichever is greater
Retail Motor Fuel Dispenser & Diesel Exhaust Fluid (DEF) Dispenser	\$ 80.00 per hour + \$85 trip fee or \$ 1.00/mile whichever is greater
Wholesale Liquid Measuring Devices	\$ 85.00 per hour + \$85.00 trip fee or \$ 1.00/mile whichever is greater
Liquefied Petroleum Gas Meters	\$ 125.00 per hour OR \$310.00 per meter, whichever is greater + \$150.00 trip fee or \$1.00 per mile whichever is greater
Electric Sub-meters	\$400 per hour + \$150 per hour of travel time, per person
Hydrogen Dispensers	\$ 150.00 per hour + \$ 150.00 per hour of travel time per person
All Other Commercial Devices	\$ 100.00 per hour + \$100.00 trip fee or \$1.50 per mile, whichever is greater

NOTE: Charges are on a portal-to-portal basis plus mileage charges and other fees as indicated.
