## FILING INSTRUCTIONS

### REQUIRED MATERIALS:

- A. APPLICATION: Two (2) completed copies of this Application Form.
- B. MAP COPIES: Eight (8) photostat positive (8 1/2" x 10") copies of ASSESSOR'S MAP PAGES showing all properties to be included in preserve; the Assessor's Map Page may be obtained from the Assessor's Public Records section.
- Reduced copies of the Assessor's Map Page may be obtained by taking the Assessor's Map Page to a blue printer.
- Large properties or non-contiguous parcels may be shown on more than one map page. Before filing, please confirm the correctness of these map copies, and the map, block and parcel numbers shown on the application form. Even the most recent tax bills occasionally bear superseded designations. The County Assessor's Office, Appraisal Information Section, can provide assistance with this information.
- C. TITLE REPORT: A current Lot Book Report and Deed Description, or Title Report, obtained from a Title Company, which specifies the entire extent of current ownership in subject property.
- D. FILING FEE: \$1,000.00 check made payable to the Alameda County Treasurer.
