# Purpose

Assist Member Agencies in complying with mandates of the Municipal Regional (Stormwater) Permit (MRP)



# Structure

- Formed in 1991 through a Memorandum of Agreement
- Member Agencies: County of Alameda, 14 cities within the County, Alameda County Flood Control and Water Conservation District (District), and Zone 7
- Program is managed by the District
- Budget: Approximately \$2,000,000/year
- Funded by Member Agency contributions
